Marek Broła teaches literary theory in the Department of English at the Catholic University of Lublin. His research interests include theory of literature and American Gothic fiction. He is presently working on his Ph.D. dissertation on the gothic writings of Louisa May Alcott.

Andrzej Filipiak teaches political theory and the history of American political thought at the American Studies Center, Warsaw University. He is also interested in religious studies. His primary field of research is the encounter between the liberal and republican tradition and Catholicism. He is currently writing his Ph.D. dissertation on the American Catholic neoconservatives.

Jacek Gutorow is an assistant professor at the University of Opole, where he teaches British and Irish literature. He has published *Na kresach człowieka. Sześć esejów o dekonstrukcji* (*The Ends of Man. Six Essays on Deconstruction*, 2001) and *Niepodległość głosu. Szkice o poezji polskiej po 1968 roku* (*Independence of Voice. Sketches on Polish Poetry after 1968*, 2003) as well as over 100 articles, essays, and reviews on American and British literature, philosophy, and literary translation. He is the author of three volumes of poetry and has translated the works of such contemporary poets as Wallace Stevens, Geoffrey Hill, Howard Nemerov, John Ashbery and Simon Armitage. He is currently working on a monograph of Wallace Stevens.

Zuzanna Ładyga is a doctoral student in the American Studies Department at Warsaw University, where she is preparing her dissertation about patterns of negativity in post-modern literature and criticism. She teaches American literature and literary theory.

Zbigniew Maszewski is a professor of American literature in the Department of American Literature and Culture at the University of Łódź. His research interests include American Romanticism and the literature of the 1920s and 1930s. He is the author of *William Faulkner and Bruno Schulz: A Comparative Study* (2003).

Marek Paryż is an assistant professor of American literature at the Institute of English Studies, Warsaw University. He is the author of *Social and Cultural Aspects of Madness*

in *American Literature, 1798-1860* (2001) as well as a number of articles on nineteenth-century American fiction, American film, and Australian literature. He contributes reviews and essays to the literary journals *Akcent*, *Tygiel Kultury*, *Nowe Książki*, and *Literatura na Świecie*.

Alicja Piechucka is a doctoral student in the Department of American Literature and Culture at the University of Łódź. Her dissertation in progress is a comparative study of T. S. Eliot's poetry and French symbolism. She has published several articles on T. S. Eliot. Her field of research is twentieth-century American poetry with an emphasis on modernism.

Tadeusz Rachwał is a professor of English and American literature and literary theory at the University of Bielsko-Biała. His many publications include *Word & Confinement. Subjectivity in Classical Discourse* (1992), (with Tadeusz Sławek) *Maszyna do pisania. O dekonstruktywistycznej teorii literatury Jacquesa Derridy* (1992), (with Tadeusz Sławek) „Lines, Planes and Solids.” *Studies in the Seventeenth-Century Writings* (1992), *Approaches to Infinity. The Sublime and the Social. Studies in Eighteenth-Century Writings* (1993), (with Tadeusz Sławek) *Sfera szarości. Studia nad literaturą i myślą osiemnastego wieku* (1993), (with Tadeusz Sławek and David Jarrett) *Geometry, Winding Paths and the Mansions of Spirit* (1997), and *Labours of the Mind. Labour in the Culture of Production* (2001).

Sabine Sielke is Professor of North American and Cultural Studies and Director of the North American Studies Program at the University of Bonn, Germany. Her publications include *Fashioning the Female Subject: The Intertextual Networking of Dickinson, Moore and Rich* (1997), *Reading Rape: The Rhetoric of Sexual Violence in American Literature and Culture, 1790-1990* (2002), and many essays in the fields of feminist criticism, gender studies, and cultural studies.

Beata Skwarska has defended her Ph.D. dissertation on contemporary Native American writing in the Department of American Literature at Adam Mickiewicz University, Poznań. She teaches English at Poznań Polytechnic.

Barton Levi St. Armand is a professor of American literature in the Department of American Civilization at Brown University in Providence, RI. His publications include *The Roots of Horror in the Fiction of H.P. Lovecraft* (1977), *Emily Dickinson and Her Culture. The Soul's Society* (1984) and many essays on the culture of New England and nineteenth-century American literature.

Susana Vega-González teaches American literature at the University of Oviedo, Spain. She has published a book on the supernatural in contemporary African-American women writers, *Mundos mágicos: la otra realidad en la narrativa de autoras afroamericanas* (2000) and a number of articles in national and international scholarly journals. Her research interests are African-American literature and popular culture as well as ethnic women writers in the U.S.

Anna Wawrzyniak teaches writing and American literature in the Department of Education and Art at Adam Mickiewicz University, Poznań-Kalisz. She is presently working on her Ph.D. dissertation on the subject of mimesis, repetition and becoming in Nathaniel Hawthorne's fiction.

Sławomir Wąciór is a senior lecturer in the Department of English at the Catholic University of Lublin, where he teaches English literature. His interests include seventeenth-century metaphysical poetry, modernist literature and art, literary theory, and relations between literature and religion. He is the author of *Strategies of Literary Communication in the Poetry of Thomas Traherne* (1989) and *Modernist Mutations – The Morphology of the Imagist Poem: Context – Text – Intertext* (2003), and the editor and translator of a critical anthology of Imagist poetry *Petals on a wet black bough – Poezja imagistyczna angielskiego modernizmu* (2002).

Anna Wortman is a doctoral student at the Institute of English Studies, Warsaw University, where she is preparing her dissertation on the life and work of the longtime FBI Director, J. Edgar Hoover. She has published several articles on Hoover and the role of the FBI in fighting gangsters in the 1920s and persecuting radical movements in the U.S. during the Cold War.

Magdalena Zapędowska is an assistant professor of American literature at Adam Mickiewicz University, Poznań. Her articles appeared in *Kresy*, *American Studies* (Poland), *Studia Anglica Posnaniensa*, *The Emily Dickinson Journal*, and in collections of essays. She received the Foundation for Polish Science Annual Stipend for Young Scholars and Scientists for 2002 and the Emily Dickinson International Society Scholar in Amherst Award for 2003. She is currently preparing a book on separation, desire, and discourse in Dickinson's poetry.
